- 3. Interest at the rate of 2% per month will become payable on all overdue accounts.
- 4. AII charges incurred in the collection of overdue accounts shall be payable by the purchaser. Such charges shall include, but not be restricted to, fees and disbursements due to our attorneys calculated on an attorney and client scale.
- 5. All materials shall be checked on arrival by the purchaser against the delivery notes, for any shortages or defects. Failure to do so will render the purchaser liable for payment for any replacements required.
- 6. Where goods are dispatched, whether "carriage forward" or "to pay", any breakages or shortages shall be for the purchaser's account, unless otherwise agreed to by us in writing.
- 7. We are not responsible for the misuse by others of items sold by us, and no liability will be entertained for delays caused by strikes, lockouts, and breakdowns of machinery or any other reason beyond our control.
- 8. We undertake to replace all items not in accordance with the contract without delay, but we shall not be held liable for any consequential damages resulting from the use of wrongly delivered materials.
- 9. Any action for the recovery of any money owing to us under this contract or for the enforcement of any right, arising out of this contract, may, at our option be instituted in the magistrates court for the district having jurisdiction in terms of section 28(1) of act 32 of 1944, notwithstanding that the subject matter may be beyond the ordinary jurisdiction of such court, and that this clause constitutes any consent which may be required in terms of section 45 of the said act. The purchaser selects as domicilium citandi et executandi the address to which the goods are delivered at which address all legal documents and processes may be served unless the purchaser notifies us in writing of any other address selected as domicilium citandi et executandi.

# <u>CUSTOMER DECLARATION</u> PROTECTION OF PERSONAL INFORMATION ACT ("POPI")
